THESE RULES AND REGULATIONS WILL BE STRICTLY ENFORCED 1. NO ALCOHOLIC BEVERAGES OR CONTROLLED SUBSTANCES are

- to be brought to or consumed on the farm. All members and guests are expected to comply with all federal and state laws and regulations, as well as local ordinances, while on the farm. Any violations of federal and state laws or local ordinances will be grounds for expulsion from membership.
- 2. SPEED LIMIT IS 10 MILES PER HOUR. This is being strictly enforced. This includes all Golf Carts as well. The first time you will be given a warning. The second time you will lose your driving privileges onto Daviess County Fish and Game property. The third time you will lose your membership. This also pertains to anyone on your membership that has a driver's license and guests that are coming to visit with you. We have speed bumps placed throughout the farm and those are not to moved or to go around them.
- 3. Children under the age of 16 must be under the supervision of an adult while on the farm.
- 4. You are allowed to have 2 guests per year. (Guest being a family, for example, brother, wife and kids) that count as 1 guest. Individuals are just that they each count as guests. All guests must be checked into the office, and you are responsible for them the entire time they are on the property. If the guest is visiting, you for the day they will be signed in and pay \$1.00. If that guest is staying the night, they must be signed in and pay \$5.00 to stay for 2 nights. Once you have had your 2 guests for the year no more will be allowed. Grandchildren and any one under the age of 18 you bring do not go against your guest privileges but must be signed in as well.
- 5. Gasoline motors must not be operated on the lake; only electric motors are permitted.
- 6. Shooting Archery and Firearms, including BB and Pellet guns is permitted in the designated shooting areas only. No Firearms are to be discharged before noon on Sunday's. No fully automatic firearms are to be fired on the farm. Glass or metal objects are not permitted as targets on shooting ranges. Children under the age of 16 may not use rifle, trap or archery unless they are supervised by an adult at all times and must be present at the shooting range. **Members only are allowed to shoot at the rifle range.** ****We are no longer allowing any guests to shoot at the rifle

range. If you are caught with a guest at the rifle range, you will lose your membership.

- 7. Swimming is permitted in designated areas only. Children under the age of 16 must be under adult supervision at all times while they are in the water. We do not allow any kiddie pools or sprinkler systems at the campsites.
- 8. <u>NO DOGS, GLASS, METAL PULL TABS OR FIRES ARE ALLOWED</u> <u>ON THE BEACH. FIRES ARE PERMITTED IN DESIGNATED AREAS</u> <u>ONLY</u>
- 9. A dog brought to the farm must be on a lease at all times and under control at all times. Barking dogs will not be allowed. Exception: hunting breeds may be released during actual training sessions but must be under control at all times. Dogs are allowed to cool off in the water but not in the swimming area or allowed to enter from the beach.
- 10. Please put garbage in the trash cans and must be taken to the dumper by the dam. Please DO NOT put any trash/ feminine products in the porta potties, please use the trash cans to dispose of any and all trash. All CAMPERS must clean their campsites before leaving. You are required to take all trash out of the trash cans and take them to the dumpsters located by the gate/dam when you check out. DO NOT LEAVE ANY TRASH AT YOUR CAMPSITES (IN THE TRASH CANS OR FIRE RINGS FOR THE CARETAKERS TO PICK UP) IF LEFT BEHIND YOU WILL BE CHARGED A FEE OF \$75.00 THE NEXT TIME YOU CAMP.
- 11. Off Road Vehicles (Motorbikes, minibikes, motor scooters, ATV, any type of electric/battery operated toy ride-Ons) are prohibited from use on the farm, with the exception of those being authorized to use them in authorized areas. E-bikes are allowed, but you must have a driver's license to ride them. Only licensed drivers can operate golf carts (not permitted drivers). The number of passengers on golf carts should not exceed the seating capacity. All golf carts must have working lights to be driven after dark. <u>NO VEHICLES ARE ALLOWED ON THE DAM. NO VEHICLES OF ANY KIND ARE ALLOWED TO BE PARKED UNDER ANY OF THE SHELTERS/PAVILIONS.</u>
- 12. All unnecessary noise must cease by 10:00 pm, Sunday thru Thursday night. Friday and Saturday nights, quite time is midnight. Playing loud radios or other such devices is prohibited. The Caretakers and Directors are authorized to regulate loud and objectionable noise at all times.
- 13. All campers must register at Caretaker's house and receive a copy of the camping rules. Upon removing the camping unit from the farm, all campers must check out and leave the camping tag with the caretakers and remove all trash from your campsite and take them to the dumpsters.
- 14. The entrance gate will be locked at 10:00pm every night and will be unlocked at 6:00 am. Code for the gate is located on the back of your membership card. If you have misplaced your card and need the code, you are to get it from the caretakers between the house of 6:00 am-10:00 pm. This is convenient for the members so they can come and go

between the hours of 10:00 pm-6:00 am. Unauthorized use of the code to the gate may be a cause for revocation of your membership.

- 15. Anyone 21 years of age or older without a handicap must have their own membership.
- 16. If you do something that any law enforcement has to be called on, upon review of the board, your membership will be banned for life.
- 17. Due to many accidents on the trails, if an incident report is claimed and filed on you, upon review of the board, your membership could be revoked. We are enforcing this rule to keep the golf cart trails open. Caretakers and Directors can shut them down and block them off at any given time due to any incidents had on the trails.

CAMPING RULES AND REGULATIONS

1. All campers must register with the caretakers upon arrival and sign upon removing the camping unit (tent, camping trailer, motor home, etc.) from the farm. Check in day counts as the first day you camp. Check out day does not count as one of the 14 camping days. Check in is between 8:00am-7:00pm only. Check out time is 8:00 am-3:00pm. No camping unit is to be removed between the hours of 8:00 pm and 8:00am. All campers should receive a copy of these rules. All camping fees are due and payable at the time you check out.

2. Any camping unit may camp on the farm for not more than fourteen (14 consecutive nights. After fourteen (14) nights, the unit must leave the farm for a period of five (5) consecutive days before returning.

3. Any portion of the fourteen-night period (i.e. 1-14 nights) shall constitute a full fourteen (14) nights. The unit must be removed from the farm for a period of five (5) consecutive days. Members may not camp during that five-day period, but may continue to use other facilities (fishing, swimming, rifle range, ect.) The club requires that the camping unit not be left unattended by its owner for a period of more than 48 hours. You are required to at least check on your unit during that time period.

4. All CAMPERS must clean their campsites before leaving. You are required to take all trash out of the trash cans and take them to the dumpsters located by the gate/dam when you check out. DO NOT LEAVE ANY TRASH AT YOUR CAMPSITES (IN THE TRASH CANS OR FIRE RINGS FOR THE CARETAKERS TO PICK UP) IF LEFT BEHIND YOU WILL BE CHARGED A FEE OF \$75.00 THE NEXT TIME YOU CAMP.
5. No camping unit may be parked in such a manner as to block other units from using that same area. A camping unit cannot occupy two camping sites. Remember a lot of our sites are more than a 1-unit site. Example being A section sites 3 & 4 (top left side of hill). Please back your camping unit into the farthest site so that another camper can occupy that front site. Be respectful of your camping neighbors.
6. A camping member using a space where water and electricity are available shall pay a fee of \$15.00 per night for the full period of time

that camping unit is occupying that site.

7. All campers, tents (or anyone occupying a campsite in the primitive area) must pay \$7.00 per night and abide by all camping rules. 8. As of July 14, 2016, NO MEMBER MAY STAY OVER THE FOURTEEN (14) NIGHT PERIOD.

9. All campfires must be contained in a fire ring and not allowed to burn anything that has nails in them.

10. You are allowed to use the dump station only if you have camped on Daviess County Fish and Game property. If you have camped elsewhere, you can't bring in your unit or portable dump container and dump to our dump station. This is only to be used while staying with us or when you leave.

11. If you have camped in Section D, sites 1 through 7 (also known as the front row) on a holiday weekend this year, you are not allowed to camp another holiday weekend on those sites mentioned about for this calendar year. You are free to camp there any off weekend if you have previously camped there just not those holiday weekends. Holiday weekends are Memorial Weekend, July 4th, Labor Day and Halloween. This will roll over at the beginning of camping season every year.

12. No campers are allowed to be parked on the road coming into DaviessCounty Fish and Game property at any time. Please refer to rule #14.13. If you piggyback camp from a member or campsite, you must be

checked in for that site, must stay at that camp site and are to pay for your nights of camping, same rules apply for the 14-day period. You are not to run extension cords from other sites or across the road when piggyback camping.

14. All campsites will now have a post at the front section of each campsite with all sites included on that post. Each campsite will be labeled by that campsite number. There will be a tag for each campsite. The tags will let you know when that member is due to checkout.

*****HOLIDAY WEEKENDS ONLY*****

You must be at Tag Station at 8am. No one before 8am will be allowed to pull tags. PEA JUG SYSTEM–First one to arrive is the first to pull a pea. The number on the pea is the order you will pull tags. Example (if you are the first one there and pull pea #6 then you will pull your tag 6th. If everyone at the board wants different spots, then there is no need to even pull a pea. If 2 people want the same spot, then everyone will pull a pea out of the jug) You (cardholder or spouse) only be allowed to choose your tag not anyone else on your membership or another member. They have to pick up their own tags. Once you have pulled the tag you will then take your tag to the caretakers and check in, pay for your first night's camping, they will fill out that tag for you to place back on the board to reserve that camping site. No more tags will be placed on campers. You will have till the next day by dark to bring in your camper. If you don't bring in your camper during those 24 hours, you will lose the deposit for your first nights camping and the site will become available for another member. 15. Once you are checked into a camp site, you are not allowed to move to another site if one should come available for any reason.

16. Effective immediately, if a relative is camping on a site, you must wait 24 hours before you can pull a tag from that site the relative was staying in. You are not allowed to put a tent up and then have a relative pull a tag right after checkout, which is considered saving a spot. If you are caught doing this, you will lose your membership!

CAMPING RULES REVISED June 2025
